

**STATEWIDE EXTENDED STUDIES
SCHOLARSHIP PROGRAM
2008-2009**

The colleges and universities that sponsor the Extended Studies Scholarship Program include Adams State College, Colorado School of Mines, Colorado State University, Fort Lewis College, Mesa State College, Metropolitan State College, University of Colorado at Boulder, University of Colorado at Colorado Springs, University of Colorado at Denver, University of Colorado Health Sciences Center, University of Northern Colorado, Colorado State University - Pueblo, and Western State College.

Criteria

All of the funds shall be used for scholarships for Extended Studies students who enroll either in credit or noncredit courses. **The scholarship shall apply only to tuition and course-specific fees for one or two courses per term and shall not be granted for student's expenses, books or other course materials.** Different amounts may be awarded to different applicants. **Recipients must be Colorado residents.** Financial need is not a mandatory criterion.

To be eligible for the Statewide Extended Studies Scholarship Program, students must meet the following criteria:

- be 25 years old or older at the time of application or have a nontraditional student life circumstance (single parent, etc.)
- be enrolled in Continuing Education for a minimum of one course (including distance and professional development courses) during the 2008-09 academic year
- have **not** been admitted to the University for the 2008-09 academic year

Incomplete applications will not be considered. Scholarships will typically be in the amount of approximately \$360. Recipients will be notified in writing. Awards are to be used exclusively for Continuing Education courses and course-specific fees.
